Powerclad Keder Sheeting is made to customer's specific sizes to accommodate any bay width and keder diameter. It is available in a heavy duty Premium FR grade for exposed locations and long-term installations or a Standard grade for short-term projects. While the sheeting itself is waterproof, the limitations of the keder design do not necessarily provide a watertight system.

Powerclad Temporary Roof Sheeting is available with keder hems or reinforced bands to fit most temporary roof systems. Powerclad FR TRS incorporates strong tear-resistant longitudinal reinforcement strips for fastening the sheeting to the scaffold beams.
